Sealed tenders are invited from the reputed and bona fide Transporters for Transportation and distribution of 1) ICDS KITS and 2) Medicines for CMS supply. The Transporters should have experiences for similar types of jobs.

All tenders are to be submitted in two separate sealed envelopes to the Purchase Manager, Gluconate Health Limited (A Govt of W.B. Undertaking), 2, Durga Charan Doctor Lane, Kolkata – 700014.

Please write “**Quotation for ICDS Kits**” and “**Quotation for CMS supply**” and the Tender no. NIT/PT – 01/16-17 on the envelopes clearly. **Please submit the tenders in two separate envelopes for two different jobs.**

Quotations send through email or fax will not be accepted.

Last date of submission of tender: 02.05.2016 up to 3.00 p.m.

Tender opening date: 02.05.2016. at 4.00 pm.

Tenderer or their authorized representatives are requested to present at the time of opening the tenders.

- 1) **ICDS KITS:** a) No. of Kits : 1,15,000 nos. apprx.
 - b) Size of the kits bag : 17.5’ x 7.5’ x 8”
 - c) Weight of the bags : 5 Kgs apprx.

Supply of ICDS KITS is a time bound program and to be completed within 2/3 months. The KITS are to be delivered to the CDPO and DPO of all the Districts of West Bengal.

- 2) **Medicines for CMS supply:** CMS supply for various medicines will continue throughout the year and to be delivered to the Govt Hospitals and DRS throughout all the Districts of West Bengal. The supplies are to be made as per the orders received from the respective places from time to time.

No EMD is required to submit to participate in the tender, but successful bidder may have to submit a security deposit in the form of draft which will be kept with the company till successful execution of the order. Security deposit will be forfeited by GHIL (Gluconate Health Ltd) if the supplier fails to comply with the Purchase Order issued by the company in part or full.

The Management of GHIL does not bind itself to accept lowest tender but reserves the right to accept or reject any or all tenders in full or part at any time prior to award of contract without thereby incurring any liability to the affected tenderer or any obligation to inform the affected tenderer, assigning any reasons. In case of acceptance of tenders even in part, tendered rate shall be valid.

TERMS & CONDITIONS

1. Transporter will submit Trade Licence and related documents along with their quotations,
2. The transporter must have minimum two years' experience for supply of medicine to all districts and other projects,
3. Number of vehicles owned by the transporter should be mentioned along with necessary papers,
4. Vehicles are to be available at our factory as & when required by us for continuous supply of medicine till completion of the job,
5. The rates will be valid up to the completion of job/supply to various places in West Bengal till further orders and no enhancement of rate will be entertained during this period,
6. Insurance cost will be borne by us,
7. If the transporter fail to deploy his truck and we are compelled to arrange the same from other transporters in higher rate, the transporter is to borne the extra cost and it will be adjusted from his bill,
8. To avoid any damage of medicines every protection to be taken from his side,
9. Penalty : For deliveries beyond stipulated time, a sum equivalent to 0.5% of the delivered price of the dealyed goods will be deucted from your bill for each day of delay ,
10. Payment : Within 45 days after submission of bill and necessary documents of delivery,

11. The transporter will have to pay security deposit of Rs.50,000/= prior to starting the work.
12. The Management of GHL also reserves the right to cancel the order in case of failure to execute the order in time and will place order on other parties. The difference of value if any, will be borne by the tenderer.
13. All the disputes, if arising out of any shall be subject to Kolkata jurisdiction only.
